Aaron also recently obtained dismissal of several medical negligence and punitive damages claims brought against physicians related to a loss of limb following surgery and a pediatric case in which the parents of an 8-year-old child claimed permanent cardiopulmonary impairment and is currently engaged as lead defense counsel for skilled nursing facilities, rehab hospitals, medical directors, nursing home administrators and medical practitioners in the defense of nursing home litigation.

Aaron also has significant past experience defending industrial injury and employer intentional tort actions, as well as high exposure environmental and commercial litigation. He practices in state and federal courts in Ohio and WV and has been admitted pro hac vice in state and federal court in over 20 other states. Aaron's health care practice includes defending skilled nursing/rehab hospitals in nursing home litigation, medical liability and professional negligence actions and other health care litigation, including wrongful death and survivorship actions and various catastrophic injury claims.
